

Hindu saints attacked under similar Machiavellian conspiracies



On 31st March last, the Bengaluru sessions court dismissed all rape charges levelled against Jagadguru Shankaracharya Shri Raghaveshwara Bharathiji, the abbot of Ramachandrapura Shrine (Karnataka). A 51-year-old woman had accused Raghaveshwara Bharathiji of raping her more than 169 times.

Shri Raghaveshwara Bharathiji's case is yet another eye opening tangible example as to how a huge conspiracy to destroy Hinduism has been going on covertly.

Hon'ble justice Mr. G.B. Mudigoudar said, "There is no evidence available against the accused (Swami Raghaveshwara Bharathiji). This case is nothing but an attempt to harass and embarrass the accused."

Besides Shri Raghaveshwaraji, there are numerous other Hindu saints who have been kept incarcerated for years under false allegations without any valid evidence. There are a number of issues in the cases against Pujya Bapuji which are similar to the case of Raghaveshwara Bharathiji, let us have a look on them:

- (1) Before filing the FIR, the accuser woman's husband demanded a ransom of Rs. 3 crore from Shri Raghaveshwaraji. The couple had even been arrested and questioned in this connection.
- ► In the same way, on August 8, 2008 the connivers had sent a fax message to the ashram in the name of Bapuji, 'Give us a sum of rupees 50 crore within a week, or else be prepared to languish behind bars along with your family. False and fabricated cases are all ready to implicate You under charges of money laundering, land grabbing and adultery.' In a sting operation, a conspirator named Raju Chandak has confessed to have conspired in the very same way.
- (2) In the case of Raghaveshwara Swamiji it has been stated in the final verdict of the court that the prosecutrix has categorically stated that earlier she had disassociated herself with the activities related to the shrine for more than six months, as such she should not have come back if she had really suffered sexual assault as alleged by her. This act of the prosecutrix speaks in volumes of her ulterior and selfish motives as well as of the sinister design clearly hatched by her to malign the accused Swamiji.
- The Surat based woman who levelled allegations against Pujya Bapuji stated in the FIR that when she lived in the ashram, during that period she also visited other cities frequently. Moreover, she even visited her parental home several times. If any such thing happened to her, why would she return to the ashram?

She says, 'The so called incident took place in 2001. And in the year 2002 her younger sister came to stay in the ashram.' If a girl were raped in some place, would she like her younger sister also to live in that place? Never.

- (3) In the verdict of the case of Shri Raghaveshwaraji it has also been mentioned, 'The accused deserves to be discharged simply on the ground that the complaint was lodged after a delay of more than 3 years from the date of the alleged first incident. Also the materials allegedly related to this case were produced after 82 days.'
- In this manner, if the time limit is so significant to prove the innocence of the accused, then in the allegations levelled against Pujya Bapuji in Ahmedabad and Narayan Sai in Surat, the FIRs were lodged after a delay of 12 and 11 years respectively from the date of the alleged incident. Yet in the Surat and Ahmedabad cases even bail has not been granted to Pujya Bapuji or Narayan Sai.
- (4) In the case of Shri Raghaveshwaraji, the statements of the prosecution witnesses and statements of the prosecutrix actually speak against their own case.
- Similarly, in the Ahmedabad case of Bapuji, the prosecutrix stated in the petition filed in the Gandhinagar court, 'I had levelled the allegation under coercion. I wish to reveal the truth by altering my statement.' Apart from this, Sudha Patel, one of the chief witnesses in the Jodhpur case, stated in Jodhpur Sessions Court, 'It is false that my statements were taken on record by the police. I neither visited Jodhpur ever before, nor had I given any statement anywhere.'
- (5) In the case of Raghaveshwara Swamiji, the mobile call details register of the woman and statements made by the eye witness indicate that at the time of the alleged incident the woman was not present there.
- Likewise, in the Jodhpur case of Pujya Bapuji, Jurist Dr. Subramanian Swamy has explained, 'Phone call records of the said girl confirm that at the time she says she was in the cottage, she was not in fact present there. Bapuji was delivering *Satsang* discourses, and finally he was busy in an engagement ceremony. He was not present in the cottage either.'

After reviewing all such aspects we can only wonder as to why even bail has not been granted to Pujya Bapuji even after a period of more than 2 years and 8 months now!

An almost identical strategy behind the conspiracies hatched to level false allegations against Hindu saints in order to prove them culprits can be clearly noticed. The inhabitants of India ought to be particularly watchful and thoughtful in order to comprehend this systematic international conspiracy against our culture and the country, and to counter it collectively.

Court Admonishes the Police

On 11th April 2016, the Gandhinagar (Gujarat) District and Sessions Court acquitted all 244 *Sadhakas* (disciples) who were nabbed in a so called case of scuffle with the police during a rally organised in Gandhinagar in 2009.

It took more than six years during which statements were given by 122 witnesses, cross examination and prolonged arguments were carried out. According to the court, "the prosecution failed to establish any allegation against the *Sadhakas* in this case. There are a number of anomalies in the charge sheet. Even the report regarding the wounded people doesn't seem to be true." While exonerating the *Sadhakas*, the court also reprimanded the police for having lodged cases against the *Sadhakas* under charges of violence and attempted murder.

This was the case:

A protest rally was taken out on 26th November, 2009 in Gandhinagar against a newspaper of Gujarat which had been running a malicious smear campaign against the ashram and Pujya Bapuji. In this rally, under a well-planned conspiracy by the evil propagandists some anti-social elements disguised as *Sadhakas* had crept into the crowd and they resorted to stone-pelting; the police in response had not only beaten the *Sadhakas* and common people which included numerous women, children and aged people ruthlessly with their batons, but also hurled tear-gas shells and finally arrested and pushed them behind bars.

On the following day, the police launched a sudden attack (raid) on the Ahmedabad ashram and vandalised the ashram. They mercilessly beat one and all with their batons and butts of their guns and made them run towards the police vans in which they were packed and then imprisoned. They were illegally kept in police custody for more than 24 hours. They were tortured physically and mentally and their religious sentiments were hurt.

Conspirators with evil intentions created this incident wherein cases were registered by Police against innocent Sadhakas under section -307 of IPC (attempt to murder) and other very serious sections.

Sadhakas including children, women,

Pujya Bapuji says, "All should make efforts to plant *Tulsi* (Holy Basil), *Amla* (Indian Gooseberry), *Pipal* (*ficus religiosa*), *Neem* (*Azadirachta Indica*) and Banyan (*Ficus Bengalensis*) trees in and around their houses and localities. Amongst them *Pipal*, *Amla* and *Tulsi* are highly beneficial. You should advise and encourage the Forest Department to plant *Pipal* trees. I shall consider that you have served God, the society and also obliged me.

It is a common notion that planting *Pipal* trees is difficult even though their glory is great. People think, 'When will a *Pipal* seed become a tree?' That is why we made experiments on *Pipal* grafting. It was successful. We have planted many *Pipal* trees on roads near our ashrams and many other places.





Steps to Pipal grafting


First of all choose an 8-10 feet long and straight branch of a *Pipal* tree. Debark about 1-1.5 inch of the branch at the bottom end. Remove only the upper bark. (See picture 1.)

Take equal quantities of soil, *Deshi* manure or *Kenchua Khaad* (earthworm manure), sawdust and mix them. Add some water to make the mixture moist. Now, apply this mixture on the debarked portion of the branch. (See picture 2.) Cover it up by wrapping polythene around it using a thin string to fix it tightly so that no insect or animal can harm it. Keep it thus fixed for about a month. (See picture 3) Do this during June-July so that it will grow roots before the monsoon begins and upon the arrival of the monsoon this graft can be planted into the soil in July-August. Roots will grow therein within a month. Then cut off the branch from below the level of the wrapped portion to separate it from the main tree. It can be planted right away or can be kept safely in a polythene bag filled with soil or may even be transported elsewhere.

Simple Remedies for Summer Problems

Nose bleed (epistaxis): Pour cold water on the head when this occurs. Instil the juice of fresh and tender *Durva* grass (*Agrostice linearis*) or the juice of coriander leaves in the nostril using a dropper. It will stop bleeding. To get complete relief take 10 gm *Amla* juice mixed with sugar candy twice or thrice a day or drink fresh sugar cane juice.

Sunburn: Exposure to sun makes the skin scorched and tanned. Apply the juice or thin slices of snake cucumber on the face, and wash it with cold water after some time. Soap



Prickly heat: Apply Fuller's earth mixed with water on the body and take a bath to get relief. Applying the mixture of ½ spoonful of bitter gourd juice and one spoonful of baking powder (sodium bicarbonate) gives relief in 2-3 days. For prevention of prickly heat consume citrus fruits containing vitamin C like *Amla*, lemon, orange etc. Wear loose cotton clothes.

Problems caused by heat and Pitta: Add one spoonful of Triphala-Ghrita to milk and take it at night. It will give relief from the internal heat generated by Pitta, headache and burning sensation in the eyes. Sucking a spoonful of Gulkand (jam or preserve of rose petals) slowly at 4.00 p.m. also helps. By taking coconut water or the juice of cucumber/snake cucumber mixed with lemon juice in the morning on an empty stomach removes the extra heat from the body through excreta, purifies the blood and provides protection against heat.

Urinary disorders: Grind 2 gm fennel-seeds in water, add sugar candy to it and give twice or thrice a day to patients of burning micturition, painful micturition (dysuria), dribbling of urine and fever. It will alleviate heat as well. Consumption of water melon, musk melon and snake cucumber is also highly beneficial.

Other problems caused by heat: Mental agitation (aggressive temper), idleness and anger caused by excessive *Pitta* are common in this season. The practice of *Sheetali Pranayama* (Please read page 26) in the morning will help greatly in these problems.

Glimpses of nationwide service works

Apart from Sadhvi Santosh bahanji and other eminent persons many narrators of the Bhagavat such as Phulkumar Shastriji, Shri Bishan Shastriji, Sadhvi Gangaji, Shri Gangadharji Maharaj, Shri Bhupendra Shastriji, etc. graced these occasions. Bhandaras were also organized on these venues.


