Most of the selfish media declared Shankaracharya guilty in their media-trials with biased attitude. The same cruelty is meted out to Pujya Bapuji also.




The Greatness of the Syllable Om

(Chaturdashi Aardra Nakshatra Yoga: 14th January)

Sutaji said to the Rishis: “O Great Rishis, The syllable Om means an excellent boat to cross the ocean of worldly existence. (Pra = Of the Prakriti i.e. the world evolved out of it. Navam- Navam Varam – an excellent boat). Or Pranava may mean- “there is no world for you”. Therefore men of Knowledge chant Pranava with this Bhava. Or ‘प्र(Pra)-प्रकर्षेण, न(na)-नयेत्, वः(vah)-युष्मान् मोक्षम् इति वा प्रणवः । It may mean “that which leads to salvation”. Or it may mean- “that which leads to new knowledge”. After annihilating all actions it gives the persons who repeat the Mantra or worship, a fresh knowledge of the pure Consciousness. This is another reason why the sages call it ‘Pranava’. (**Pra-** the destroyer of karmas, and **Nava-** the giver of fresh knowledge.)

The Maheshwara (Supreme Lord), Who is devoid of Maya (the power of illusion) is Himself known as “New”. That Supreme Lord is primarily the Pure Being; and hence called the Pranava. –That Supreme Lord is primarily **novel**, i.e. the Pure Being. Pranava awakens the sadhaka who recites it into a new Consciousness, Shiva Consciousness; this is another reason why the wise men know it as the Pranava. Alternatively, it may mean the Supreme Self Who reveals divine Knowledge.

Though a *Jivanmukta*, (one who is liberated while living) who is perfectly enlightened and accomplished, doesn’t need any sort of spiritual practice; yet the practice of japa of the ‘pranava’ is done by Him spontaneously. The Pranava is two-fold (1) the subtle (2) the gross. The subtle one is for the *jivanmukta*. The need for the contemplation of the meaning through the Mantra is only up to the destruction of the physical body. When the body is destroyed he completely merges in Shiva Consciousness (Absolute Brahman) undoubtedly. The mere repeater of the Mantra attains the yogic communion with Shiva certainly. A person who repeats the Mantra 360 million times certainly attains the yogic communion. Shiva, Shakti and their union are indicated by the syllables “A”, “U” and “M” respectively. Shiva, Shakti and their union are indicated by “M” syllable ramified into three and this is called the short subtle Pranav. The short Pranav shall be recited and repeated by those who desire their all sins annihilated. The Pranav is to be used in the beginning of the Vyahritis (seven mystical

utterances), mantras, in the beginning of the Vedas, and during the prayer at dawn and at dusk along with Bindu and Nada.”

Lord Shiva once said to Lord Brahma and Lord Vishnu: “I have taught this great auspicious Mantra. Omkara came out of my mouth. Originally it indicated me. It is the indicator and I am indicated. This Mantra is identical with me. The repetition of this Mantra is verily my repeated remembrance.”

“O Sages! By repeating it daily for a thousand times the devotee becomes perpetually pure. O Brahmins, there after the repetition of the Mantra is conducive to the achievement of desires.

‘A’, ‘U’ and ‘M’ –these three syllables of the ‘Pranava’ indicate the oneness of the *jiva* (the individual soul) and the Brahman (The Supreme Self). One should do japa of the ‘Pranava’ or ‘ॐ’ (AUM) keeping this fact in mind. One should contemplate while doing japa of Omkara: “I am worshipping Brahma, the Creator of this world, Vishnu, the sustainer of the world and Rudra, the destroyer of the world; who is self-illuminated Consciousness personified. May the Brahman personified Omkara direct the tendencies of my organs of action, sense organs, mind and intellect towards Dharma and Knowledge that give enjoyment and salvation.’ One, who does japa while contemplating as above in his mind, will certainly attain to Brahman, the Supreme Self. Alternatively, one should always do japa of the ‘Pranava’ even without contemplation.


Failure of the Conspirators Victory of Truth & Dharma

Shankaracharya is Innocent

Pujya Shankracharya Shri Jayendra Saraswati was trapped in the case of the murder of Sankararaman, manager of the Varadarajperumal temple of the mutt. Nine years after being charged with criminal conspiracy in the murder Kanchi Shankaracharya Jayendra Saraswati was acquitted by a Puducherry court. The Postmortem of the FIRs lodged against Puja Bapuji and Shri Narayan Saiji - Senior Journalist Shri Arun Ramtirthkar

It is known to you all that different FIRs have been lodged in Jodhpur and Surat levelling abominable allegations against Puja Bapuji. But it is only after going into the details of those FIRs that one can easily understand about what is written therein, how far they are true and how blatantly false they actually are.

First we shall examine the FIR lodged in Delhi by the UP girl. She declares herself to be legally a minor, but at the same time tells that – “I am a student of standard 12th”. The school records reveal that the girl spent 2 consecutive years in the 7th standard. This calculation puts the age of the girl at the time of her admission in the 1st standard even less than 5 years; whereas for admission in that level of a school mandatorily requires one to be 6 years old, or 5 years at least. What is noteworthy here is – neither the Jodhpur Police nor any channel thought it necessary to find out whether she is a minor or a major.

Ajmal Kasab, originally belonging to Pakistan, declared himself to be a minor. It was simply impossible to unearth his school or the birth certificate. Pakistan was not ready to even accept him as its citizen. He was sued only when the Indian doctors medically examined and declared him a major instead of a minor. Even so, it is extremely necessary to ascertain through a medical examination as to whether the girl is a minor or major in the Jodhpur case. Here we must note that it is only in the case of the concerned girl being a minor

that the non-bailable ‘Pocso Act’ is enforced, which is a part of the conspiracy to enmesh Asharam Bapu.

In the next phase of the conspiracy Bapuji and Shri Narayan Sai were entangled in cases of rape and sexual harassment using two sisters of Surat as pawns. Both these sisters are married. The elder of them (33 years) has accused Bapuji, while the younger one’s (30 years) allegation is against Narayan Sai. However, their FIRs themselves expose the well planned conspiracy of the perpetrators. Let’s have a look at some aspects of those FIRs:

The elder sister says that the so called event took place with her in the year 2001. Whereas it was in the year 2002 that her younger sister came to stay in the ashram. Just imagine, can a woman, who has been raped somewhere ever like her own sister to stay there? No way! Here the simple question arises as to why she didn’t forbid her younger sister from coming to the ashram? If she was afraid of telling the truth at that time, she must have stopped her sister using some excuse. But this did not happen. Why?

Any lady of noble descent would hate the man who has raped her, and tries her best to keep away from him, whether or not she has launched a complaint against the same with the police. But here the woman (the elder sister) in question always had a very good behaviour record with Bapuji. Had the filthy matter she has written in the FIR been true, it was imperative on her part to leave the ashram

immediately. But the lady went on to become a speaker of the ashram. She gave discourses from the stage and sang hymns in praise of Bapuji in front of thousands of devotees. This amply proves that the allegation, which she has brought against Bapuji is completely fake, nothing such ever took place. The elder sister says, "I was very much frightened after that event of rape in 2001 and sought to flee away from the ashram, but couldn't find an opportunity for that." Whereas, she has herself stated in the FIR that she continued to visit other cities during this period. The fact is that she repeatedly moved to various small towns and cities such as Baroda, Anand, Nadiad, Bharuch, Mehsana, Ludhiana, Rajpura, Amravati, Ahmadnagar, etc. in the course of giving discourses. And she visited even Surat, her home city (where her father's home is), time and again. She had once again visited her homeland while suffering from T.B. So, couldn't she find a single good chance of fleeing away in all these 6 long years? Couldn't she have got enough opportunity to inform the police or her family people? Why did she need to plan her escape? The elder sister has stated in the FIR that after the so called rape she was taken on a vehicle to the Shaligram Apartments and dropped there, from where she came to the Mahila ashram on foot. The distance between the Shaligram Apartments and the Mahila Ashram is about half a kilometer. Had there been any trace of truth in the story of the woman, then why didn't she make use of the great opportunity to escape from there only? There are so many households and shops near Shaligram, and a good number of people throng that area too. Under these circumstances she could easily have gone to her own house, asked someone for help or even approached the police as well. Why didn't she go for any of them?

The younger sister has accused Narayan Saiji of having raped her in Bapuji's hut; whereafter she went home. And on the very

next day, she went to Saiji's Himmatnagar Mahila Ashram; for which she explains that Sai had himself telephoned her to do so.

First of all Saiji never stays in Bapuji's hut. Secondly, it is beyond sane comprehension as to why a woman who is raped one day and the next day she leaves for her home and again decides to leave the most secured place in the world – her home – to go and stay at the ashram instructed by the same Saiji; and there too she stayed for two long years serving the ashram with full dedication as a director? This itself is a proof enough that nothing untoward happened with that woman ever in the ashram, and that it is due to sheer avarice that she has taken this well planned step to malign the immaculate character of Saiji.

The younger sister explains that when she went to the ashram for the second time, no incidence of molestation or anything of the sort took place; and hence she regained her faith in the ashram. Then again she claims that while she stayed there in the ashram for 2 years as the director Saiji continued to harass her whenever he came to the ashram. All these statements are self-defeating and simply ridiculous that as she found no one molesting or disturbing her otherwise for the first few days, she got her faith reinforced and that she continued to stay in Saiji's ashram tolerating all sexual harassments meted out to her during those two years! Whereas it is difficult to digest as to how she didn't get a chance to flee away from the ashram which is so openly situated in the Gambhoi village of Himmatnagar (Guj.)? That is not all, that lady was well acquainted with the local people, and she used to go to the market and the city regularly.

According to the younger sister she left ashram in 2004 and she got married in 2010. Even then she said absolutely nothing about all this to her parents; and it was only on 1st October 2013 that she revealed all this to her husband and lodged an FIR on 6th October 2013 for the first time. How is it possible for a

about her suffering and pain to any of her relatives for 11 long years? A medical test after years of the event is not going to reveal any reality. Whereas, the medical report has an important role to play in a rape case.

The younger sister says that after that harassment she handled the post of a director in an ashram of Saiji. After serving the ashram for two years she left the ashram and went back home. Being the chief director of the ashram she had the responsibility to complete the formalities regarding the accounts of the ashram, so Saiji called her through a phone call. So she left for the ashram. Enroute to the ashram she stayed with an acquaintance for a night. She was to leave for the ashram from there, and she had informed Narayan Sai about the same over the phone as well. Further on this lady has got it noted down that some 6-7 ladies sent by the ashram pelted stones at the residence of her acquaintance, frightened by which she went back home. How bogus are all these statements! Had the event of pelting stones been true the master of the house or the neighbours would have registered a complaint against it with the police? There is simply no proof of the stone pelting event whatsoever. If Narayan Sai wanted to call her to the ashram, and when she herself was ready to go there; then why should he arrange for stone pelting at all? Even a layman does have this much of common sense.

The younger sister left ashram in 2005 for home, and yet the elder sister didn't ask her the reason for her leaving the ashram; and even the younger sister didn't find it necessary to give any reason for the same. Is it possible between two close sisters? The younger sister puts it like this, "I was so frightened that I fled from the ashram showing a lame excuse. After 8 days, upon getting informed by a lady, I telephoned to Narayan Sai." But when she had left the ashram for good, why should she telephone back to Narayan Sai just because some lady has informed her about it? This again proves

that nothing of the kind took place at all.

Both the sisters have got it noted down in the FIR, "We could say nothing to anybody owing to their great leadership and influence, and have told nobody about this till date." In the year 2008 the state government had got it published in the local newspapers of Gujarat that anyone who wants to complain against the ashram, the police would go to the residence of such a person and get the case registered there itself; and that the names of such people too will be kept secret. Despite this ease given by the government why didn't these two sisters come out with their complaints at that time? And what is more astonishing is that even after 6-8 years of leaving the ashram they were never even contacted to by the ashram, let alone giving any kind of threat or harming them in any way despite the so called leadership and influence of Bapuji. Whereas a rapist, who has millions of followers both in the nation and abroad, would always be in the fear that such a lady would reveal the facts after leaving the ashram. Contrary to this, neither Bapuji nor Narayan Sai had any such fear ever in their minds.

On enquiring the villagers it was revealed that the two sisters continued to go to the satsang programmes even after leaving the ashram. Moreover, the younger sister had come to have *darshan* of Saiji at Bardoli (Guj.) even in the current year 2013 itself, the photographs and video clippings have been presented before the honourable court; wherein both husband and wife are seen having darshan of Saiji with great faith and devotion. So, notable point here is -whether anybody who has been sexually harassed for years together can ever have so much devotion for her oppressor? Even a layman going through these details of the FIR would easily find it to be a well planned conspiracy to enmesh Sant Shri Asharamji Bapu and His son Shri Narayan Sai. Then there are more

such aspects to this case. It is actually an attack on the Indian culture itself that has taken shape in entangling one saint after another like Kripaluji Maharaj, Swami Keshwanandaji, Swami Nityanandaji etc. and presently Pujya Bapuji and Narayan Sai through false allegations. It is also a matter of great concern that the channels made it public with great fanfare when the above mentioned saints were entangled under false allegations; but why didn't they find it necessary to show it to the public when those saints were released with full honours? It has been the very same even upon exposure of all the conspiracies so far hatched against Pujya Bapuji.

Such a big number of falsehoods are simply enough in themselves for any intelligent man to comprehend the truth of the matter. For one, used to speaking and writing the truth always, would never commit such mistakes ever. However, when false and imaginary stories are created, people often commit such mistakes as – who was present there and who was not, what actually happened, etc. Therefore I appeal to all my fellow countrymen that they should see things using their own conscience and not through the spectacles of the media.

Media is Misguiding

Narayan Sai was not fleeing anywhere at all, he had already got it published in the newspapers of Surat that – “I am not an absconder, and will come to the fore too at the right time. All allegations levelled against me are simply false and baseless. I have taken refuge of the honourable court according to the law of the land. I have complete faith in the judiciary system and am waiting for the conclusion of the legal proceedings. According to the constitution everyone has a right to apply for a precautionary bail plea to defend oneself against false allegations brought against him.”

With the help of the judiciary system of the

country Saiji had been engaged in defending himself and other innocent people from the conspiracy hatched by the perpetrators. Therefore, it is totally unjust to spread mindless and confusing messages against him. If the threatening messages being received by the inmates of Saiji's ashram are anything to go by, the purpose of the conspirators is extremely wicked. They have gone to the extent of threatening – “We will not leave him (Saiji) alive! Wherever we can trace him, we will kill him then and there. If he is not available outside, we shall kill him inside the jail premises itself. We have access to the highest level (of power). We shall destroy and demolish all the ashrams one after another. By now, you must have assumed the power that we have.”

The terrorist attack on Saiji's Sahitya Kendra at Jaipur and the threatening given to the inmates thereof as well as the FIR lodged in the wake of these events and the complaint letter handed over to the Police Commissioner constitute enough proof to support this fact. According to the experienced people it could be fatal for Saiji to reveal himself directly to the public. In a situation, wherein there was every possibility of killing him through say food items, medicines etc., it was by all means advisable on his part to fight the legal war from his hiding until the arrival of the final verdict. Because conspiracies are afoot against Pujya Bapuji, Narayan Sai and the ashram for the last so many years now; and under such circumstances it is his constitutional right to protect himself till the outcome of the judicial process. By proclaiming the Gujarat Police as well as the sessions court of Surat to be wrong, the honourable High Court of Gujarat has nullified the non-bailable warrant against Saiji and declared that right from the very beginning of this episode and till the very end thereof Saiji was not at all an absconder; and also that it was wrong to call him an absconder.

A Vaishnavite sadhu came to stay in the ashram. He said, “Babaji! Would you please let me stay here?”

I said: “Who else would stay here if not a sadhu!” He stayed here for several years. I had given him the pet name – ‘Brahman’. One day I stood behind him and saw him intoxicated with divine joy in meditation. I said, “O Brahman! What are you doing?”

He said, “Guruji! My prayers have been answered. I have presented offerings to you.”

“How did you offer and what?”

“Guruji! I was presenting an offering of 50 kilograms of *laddoos* to Your Holiness!”

“Hey, what do you mean? You have not placed even one *laddoo* over here!”

“Guruji! The mental mode of worship is far more effective than the *Shodasho-pachara puja* (performance of sixteen points in idol worship). So I mentally bathed You, clothed You and then adorned You with garlands of roses and jasmine. Then I applied sandalwood paste *tilaka* on Your forehead. Right after waving lights ceremoniously before You, I brought *desi* ghee and prepared 50 kilogram *laddoos* with it, and mentally offered them to You.”

“So many *laddoos* and that too prepared with *desi* Ghee?” “Guruji! I had to do mental worship. So I prepared with *desi* Ghee. Why should I prepare with

vegetable ghee? (as it does not cost a single rupee).

He was really feeling very delighted and I too am greatly delighted remembering his gladness.

I have heard another story wherein two sadhus, who were friends, were on their way to a pilgrim place. However, on getting no alms at all they decided to feed themselves with imaginary food. Both of them made foods as per their own imaginations. Then after offering the mentally prepared food to their respective presiding deities, they began to eat the same. One of them said, "Wow! What a delicious dish it is! Wonderful! Raisins too are very tasty!" The other sadhu said, "Alas! O my God! What a hot chilli in this spicy curry is! My tongue is literally burning!"

The first monk queried, "What's the matter? What are you eating?"

"Oh, I happened to add many green chillies to the curry! Oh I am undone!"

"Hey! Why are you whining like that? Oh, poor fellow, if you had to live on imaginary food, why did you prepare the curry with so many hot green chillies? You really look very pathetic in such a miserable state! I on my part cooked such a sweet halwa for myself! After preparing the food of my choice I offered it to my presiding deity; and now I am savouring the same. Why did you create trouble for yourself?"

"It's all due to my misfortune. I am destined to eat such food only."



From the Darkness of Ignorance to the Light of Knowledge

(Makara Sankranti: 14th January)

The day on which the Sun-God enters on his northward journey is celebrated as the Uttarayana festival (*Makara Sankranti*). From this day onwards the night (darkness) becomes shorter and the day (Light) becomes longer. The literal meaning of 'Uttarayana' is the Sun's northward movement, whereas the meaning intended to be conveyed by this term is that we should become detached from the lower desires by the grace of the Lord of the heavens (the Sun). Lower chakras are the seat of desires and sensual attraction, and the upper chakras the seat of selflessness, divine love and bliss. The festival of *Sankranti* has been instituted by the sages for changing the course of our life. On this pious day, you change the direction of your thinking and actions. Your thinking (mental attitude) will determine your thoughts and your thoughts will determine your actions. To give all comforts to the physical body composed of flesh and bones, and to enjoy sensual pleasures is the aim of western thought and to restrain the desires of the physical body through sense control while remaining engaged in the pursuit of awakening the man present before one into his supremely auspicious nature wishing his good even in the most trying conditions is the ideal of Indian thought.

Actually, there is a date of *Sankranti* in every month of the Hindu calendar. However,

the *Makara Sankranti* does come but only once in a year. Bhishma, the grandfather of the Pandavas, waited on his death-bed of nails for the onset of this season before finally departing from the earth-plane.

A day for earning religious merits and health

One who doesn't take a bath on the day of *Sankranti* would remain sick and poor in his seven next lives; and one who takes a bath on this pious day becomes bright and earns religious merits too. One should apply an ointment made of black sesame seeds before taking bath on this day.

Offer an oblation of water mixed with sesame seeds to Sun-God. On this day giving of sesame seeds destroys sins; eating sesame seeds restores health; while a *havana* performed with sesame seeds helps one earn religious merits. Even drinking water mixed with sesame seeds is good for health. The ointment made from sesame seeds too is conducive to health. One, who takes bath on this day before sunrise, does earn religious merits equal to that earned by donating as many as ten thousand cows. Any virtuous act that is performed on the day of Uttarayana bestows imperishable religious merits. Taking sweet dishes made from sesame seeds and jaggery, and the *khichadi* made with rice and split grams helps in prevention of diseases caused by the change of season. One taking a

bath with water mixed with sesame seeds enables one fight diseases and distress caused by the change of season.

Mantra to propitiate Sun-God

The Knowledge of Brahman was first imparted to Sun-God. He imparted it to Manu who imparted the same to Yama. Thus the Knowledge of Brahman was successively passed on to others through Guru-Shishya Parampara. Lord Bhaskara (another name of the Sun-God) is a perfect *Brahmajnani*. He is absolutely spotless and desireless. And who can ever match him in selflessness and dutifulness? He neither desires for anything, nor does he have any sense of attachment or aversion towards anyone. Being established in Existence Absolute he showers light upon all, and he goes on giving like that. The Moola Mantra of Sun-God is given in the Padma Purana: ॐ ह्रां ह्रीं सः सूर्याय नमः । i.e. “*aum hram hrim sah suryaya namah*”. One doing japa of this mantra with the intention of Self-love and Self-Bliss while remembering Sun-God with devotional love develops intense love for God and gets inner joy.

Sun Salutations for radiance, strength and power

Practice of Sun Salutations increases radiance, strength and intellect. Man becomes radiant, strong and intelligent by doing Sun Salutations while chanting the mantras such as ॐ सूर्याय नमः । ॐ भानवे नमः । ॐ खगाय नमः । ॐ रवये नमः । ॐ अर्काय नमः ।... i.e. “*aum suryaya namah*”, “*aum bhanave namah*”, “*aum khagaya namah*”, “*aum ravaye namah*”, “*aum arkaya namah*”, etc. It gives benefits of both physical exercise and *Pranayama*.

Worship of Sun-God, offering oblation to Him, sun-bath and meditation on His form etc. help in fulfillment of one's wishes. Concentrate to the chakra located at the middle of eyebrows on the Sun to increase your intellect. Concentrate to the navel chakra on the Sun to cure indigestion and improve health.

Health booster Sunbath

Food products like Ghee, oil etc. when kept in the sun for 2 to 4 hours become easily digestible. One may occasionally take bath with the water exposed to the sun for a while. It prevents rickets and increases immunity.

The curative effect of sun-rays is highly sung in a few verses of the Atharva Veda, Kand 1, 22nd Sukta as well.

I myself take sunbath everyday for 15 to 20 minutes. Taking sunbath in the supine position is all the more beneficial; but one must take the sunbath during the period of 1 to 1.5 hours from the sunrise, when the sunrays are mild. This livens up the muscles and eradicates nervous debility. I have personally experienced these benefits of sun-bath. I don't have nervous debility. One suffering from nervous debility, physical weakness, lassitude or general debility should take sunbath every day.

Sunbath also cures skin diseases, and strengthens the bones. It increases the levels of calcium, phosphorus and iron in the blood; while regulating the endocrine glands. The sunrays improve and regulate peripheral blood circulation in the body. It increases red blood cells count in blood. It promotes blood formation (haemopoiesis). It also helps in cases of gout, paralysis and arthritis. It destroys pathogens, and alleviates neurological diseases, lethargy, listlessness, depression, jealousy-hatred, etc. The sunrays also play a vital role in steadiness of mind. Sunbath, when taken regularly, increases mind control, hormonal balance, besides enhancing the tone of skin and muscles, and tolerance. A regular course of sunbath can cure the tooth-diseases. Sunrays cure diseases caused by deficiency of vitamin D like rickets, and infectious diseases.

Therefore, you too should keep the food grains and the bath-water in the sun for some time, and take maximum benefits of sunbath.

Following is the conclusion of the group discussion held by D.D. News on 'Excess of Media' on 27th October.

D.D. News: The latest example of endless news and meaningless debates, and news coverage is Asharamji Bapu's topic. The allegation of sexual assault on Asharamji Bapu is certainly news but in the debate on that news; how much the welfare of the society and women is discussed – this is worth consideration. The thought or close examination on the news has to be logical. Why are they presenting the news; which is not that way?

Shri Pramod Joshi, Senior Journalist and writer: The news published in newspapers are also distorted. Excess has been done in the case of Asharamji Bapu; there is no doubt about it. The commercialization (of the media) needs to be checked.

Shri Vinit Kumar, Media Analyst: Today the media has problems with Asharamji Bapu. The entire problem that the media has with public sector establishments is that they did not give the advertisement-packages to the news channels. On the name of journalism when the media channels raise fingers on them they are preparing grounds for

the industry (boosting the paid-news).

Viewer 1: Media has to be controlled. It has a responsibility towards the nation.

Viewer 2: The important news are not shown just because the media is continuously showing news about Asharamji Bapu.

Shri Qurban Ali, Former B.B.C. Correspondent: Media has gone crazy. The media is showing and doing all sorts of nonsense things only for the sake of TRP. If they want to make money only; then there are many other businesses.

Viewer 3: Media should show the news and points. It is very painful that we have to see the scrolls for the news; we have to search news in the scrolls.

Viewer 4: The news has become reality shows in a way.

Shri Vinit Kumar: It is not only the morality in news that matters; it is a question of law also. The misinforming channels should be sued.

Viewer 5: Whatever the media's scenario we are seeing; the media doesn't seem to be the fourth pillar of democracy any more.

Viewer 6: The TV channels show whatever they want; and in their own way. What does the public say and hear;

how much loss it causes to the people; they are least concerned with that. The important news are never broadcasted.

Viewer 7: We don't feel like watching these news channels. They have completely lost their importance.

Viewer 8: Today's media knows only to sell its news.

Shri Avinash Pandey, C.O.O., ABP News: The people are right that nobody should be dragged that much; and that should not be shown the whole day. This is media's 13 years old business. Every news channel needs money to run it. And, you can never recover that money through advertisements.

(Then what are the other ways of recovering money? And what is the secret of endless and meaningless group discussions and the news coverage; all of you must have come to know it. – **Senior journalist Shri Arun**


An Inspiration to Model Education

Pandit Madan Mohan Malaviya's Birth Anniversary:
25th December

The impressions of devotional love and patriotism received from his mother during his childhood absolutely established Pt. Madan Mohan Malaviya as a role model and source of inspiration in the hearts of millions of people. He was a great thinker. As a student, he used to ponder, 'Why the students of our country need to go abroad for higher education? The students who go to foreign countries are demoralized. Why not start ashrams in our country to reinstate the ancient ashram education system?' Malaviyaji wanted to open such centers for education based on the tradition of ashrams along the banks of River Ganga from Prayag to Kashi. He tried to convince some people of his plan. Some did not pay attention to his talks and some ridiculed him saying, "Malaviyaji! Have you become crazy? Have you lost your wits? How can it be?"

Malaviyaji was a great optimist. He wanted to mould new India into a developing nation. He dreamt of reestablishing world renowned universities like 'Takshashila' and 'Vikramshila' of our ancient Indian civilization, and he verily materialized his dream. He presented a priceless gift in the field of education & culture to India in the form of Kashi Hindu Vishwa Vidyalaya.

Committed to simplicity & purity in his life, Malaviyaji never considered the secular education imparted in schools & colleges as integral education. He used to say, "Don't enter this university for the attainment of only secular education but also for character building. **The synthesis of knowledge and character gives rise to the sun of love in life which brings glory**



to the nation and the society."

Malaviyaji laid great emphasis on the need of physical & mental health of children. Espousing the need for physical exercise in his university, he said, "First become healthy and then learn. A healthy mind resides in a healthy body. Then one gets the real benefit of life. So do physical exercise every day in morning and evening."

Shri Malaviyaji was an ideal vice chancellor of Kashi Vishwavidhyala where some poor students also lived. Mahamana Malaviyaji used to give them clothes, books and money. During winter season, he used to distribute blankets to such needy students. He observed a rule to ask every day any student about his problems and to solve it.'

One day he asked a boy, "Do you take milk?"

The boy replied sadly, "I am very poor."

Malaviyaji made arrangement for him to have milk every day. Such a magnanimous and generous soul was Malaviyaji! He insisted that the students should attend the religious celebrations,

discourses on the Geeta and Ekadashi katha etc. for inculcating good traits in them. He used to say, “You’re the descendents of great Aryans. So be learned and courageous like them, and make a name of India. When you will become a scholar, you’ll know the value of time and when you will become strong you’ll defend yourself. Also learn to respect your parents and teachers.”

All round development of the students was the main objective of Malaviyaji. He would ignore even rules and regulations of the university in certain cases for this objective. Jaykumar was a very intelligent student of the final year of ‘Acharya’ degree course. Due to sudden demise of his father he had to go home to perform the last rites of his father. Due to delay in his arrival he couldn’t make up for the required attendance. Consequently he was declared ineligible for appearing in the examination. His teacher Pundit Ambika Prasad advised him, ‘Write an application, and see Malaviyaji. Read this verse out to him which implies, ‘The promptness that you showed to save Draupadi and to protect Gajendra, O Compassionate Lord! Where has the same promptness vanished in my case?’ The student acted likewise. Reading the sacred verse the student became overwhelmed by emotions and he wept in front of Malaviyaji. On hearing this verse eyes of Malaviyaji also started shedding tears profusely. Immediately he wrote on the application itself, ‘Allow him to appear in the examination.’ After a few days the student appeared in the examination and topped the university.

Revered Bapuji always thinks good of everybody from all aspects. He does not think ill of anybody. Guru Nanak says about those who indulge in denigrating such a saint:


संत की निंदा नानका बहुरि बहुरि अवतार ।

You cannot subvert an enemy which does not want to be subverted. 



Why the Guardians of Law make a Mockery of the Law?



Ahmedabad, 21st November: The police itself; the so-called guardians of law; have done a breach of the law by carrying out a search of the Ahmedabad ashram without showing any search warrant. 10 vehicles of Surat police came in the ashram at 6.15 a.m. in the early morning; and they captured the telephone office of the ashram; and sent everybody out of it. The telephone office was under police control till 5:00 p.m. Police forces were deployed at different places in the entire ashram. The entry of the visiting devotees and the exit of the ashram sadhakas were prohibited. The police had also brought with them Amrit Prajapati and Mahendar Chawla, known for their antisocial criminal activities, with masks covering their faces.

A team of the police under the leadership of the DSP Shobha Bhutada took Amrit Prajapati and

Mahendar Chawla with them and started searching all the rooms of the ashram. The locks of the rooms; whose keys were not available or if the keys were delayed; were broken with grinders (cutters). The police did not allow the sevadharies to enter the rooms when they were searching them. What things and what documents they took away from there; nothing was told to anybody. In such a case; the police can create false evidences by adding anything to the documents from their side. The F.S.L team occupied the account room the whole day. What papers and what data they took away from there; nothing was told to anybody.

The police wearing shoes entered sacred places like Moksha Kutir, Shanti Kutiya and Vyas Peeth etc., transgressing limits of decency; where the devotees bow their heads with devotional faith; and do mantra-japa and meditation. It deeply hurt the religious sentiments of the devotees. The devotees; who were doing morning sandhya-prayer in the satsang mandap; were forced to remain there in the name of enquiry. The devotees sitting there since 5 a.m. were not allowed to go from there till midday even for answering the call of nature.

Senior advocate Mr. B.M. Gupta immediately arrived at the ashram on being called; and he enquired the devotees about the police action. Expressing deep anguish over the illegal activity of the police in the ashram. He said before the media: ‘The law says that even if the police have to make a raid; even then they must have a search warrant issued by a magistrate or an authorized officer. But these people came without any search warrant even. Whatever things the police confiscates from this place; its list has to be made; and its copy has to be given to the ashram; and they also have to submit the list of the seized things to the court. Only then they can take these things after getting the order of the court. But whatever they have been doing is actually illegal.’

After the statement of the advocate; there was commotion among the police people. Many police vehicles came in the ashram from outside; and many vehicles went outside as well. The proposal was given to the director of the ashram in the evening at 7.15 pm. The proposal carried the message, ‘We suspect that Narayan Sai and other two persons are hidden in the Ahmedabad

ashram; so we want to search the ashram.’ The director signed the proposal with time and date. The police objected about the time written near the signature; because it would expose the illegal search of the ashram made by the police before the court. The police went out of the ashram after 14 hours at 8.15 pm at night.

The police told the ashram director about the reason of police coming to the ashram after 13 hours of searching. The police entered a religious organization and kept the telephone office under its control for 11 hours without showing any reason. The outsider devotees were not allowed to enter the ashram. Has the police made a new law that permits them all these things?

Why did the police search the ashram with the help of Amrit Prajapati and Mahendar Chawla; who have records for conspiring criminal activities against the ashram; and who have been alleging the ashram with false, concocted and obnoxious accusations? If they were brought legally; then why were they masked? How did the media get the video-clips taken by the government camera during the search operation? Not only this the police even showed the Mauna-mandir (a Pyramidal room made for mantra-japa & meditation) as a secret underground cell. Actually there is no underground cell in the ashram. The ashram had already been given a clean chit by the CID after many extensive investigations. Why did the police misled the people of the country? All these activities smack of a massive conspiracy.



The concocted story makers will be in the grip of law now. Complaints Registered in Police against Amrit Prajapati & Mahender Chawla

Ahmedabad, 1st December: Amrit Prajapati and Mahender Chawla had made objectionable statements against the women and sadhvis of the Mahila Ashram and concocted stories on TV news channels for their character assassination. Two woman devotees of Sati Anasuya Mahila Ashram got the FIR registered at Chandkheda police station under article No.354(A)(1) (IV), 509 & 114 of IPC by giving three complaint letters and producing a recorded CD of such news. Similarly another woman devotee complained against Mahender Chawla under the above said articles in the same police station. The complainant women devotees are from well to do families. One of them is a post graduate; and other two are Ayurvedic Physicians (Doctors) having BAMS degree.

Amrit Prajapati, who was dismissed from the ashram, was found involved in many criminal activities; and he has been jailed also. A young Ph.D scholar of Baroda Music College, Mr. Harikrishna Thakur, died in April 2009 due to negligence of his physician Amrit Prajapati. He has been involved in looking lustfully at women and harassing them. Amrit Prajapati's profligate lifestyle, greedy nature and demoniacal disposition were exposed; when an FIR was registered against him for his evil deeds in Kota Police station, Rajasthan. Amrit Vaidya was arrested under article 295A, 499, 500, 501, 384, 296, and 298; and the case is still running. Recently a woman devotee of Mahila Ashram Chhindwara got an FIR registered against Amrit Vaidya under under articles 298, 500, 505 and AIT Act 66.

A recipe for strength, intellect and eyesight

Ingredients: Almonds 5 grams, poppy seeds 10 grams, *Magajkari* (a mixture of equal quantities of powdered seeds of cucumber, musk-melon, water melon, pumpkin and bottle gourd) 5 grams, black pepper 7.5 grams, *Maalakangani* (*celastrus paniculatus*) 2.5 grams, *Gorakhmundi* (*Sphaeranthus indicus*) 5 grams.

Method: Steep the above mentioned mixture in an earthen pot in a glassful of water. Strain the water in the morning and drink it. Then grind the residual mixture into a fine paste. Fry the paste in *desi* ghee on a low flame until it becomes red. Add it with some sugar to 400 ml of milk. Sip it slowly.

A 15 day course of the above mentioned recipe would not only enhance your physical and intellectual power, but also improve your eye-sight greatly. The almonds, poppy seeds and *Magajkari* help reinvigorate and strengthen your brain. *Maalakangani* increases your intellectual power. Besides augmenting your retentive faculty and memory it also nourishes your brain and nerves. Thus, it is extremely beneficial in *Vata*-generated ailments like

hemiplegia, arthritis, tremors, etc.; in breathing problems, joint pains, insomnia, chronic fever, etc. caused by physical debility. It is also useful for emaciated and debilitated patients suffering from diabetes, etc. as well as for those doing brainwork and students. It nourishes muscles and semen.

Amla- a wonder fruit (Indian gooseberry)

Amla (*emblica officinalis*) is an excellent *rasayana* (a substance which prevents aging and promotes longevity). It promotes semen formation. Its regular use gives vigour, energy,



stamina, agility and vitality. It not only helps in healing of a fractured bone, but also strengthens the teeth. Its regular consumption increases longevity, memory, and strength. It strengthens the heart and the brain. It makes the hair-roots stronger and darkens hair.

The fresh juice of amla contains 20 folds vitamin C than that of an orange. Consumption of amla is beneficial in symptoms of

tachycardia, cardiac weakness and disorders of blood circulation. It also enhances the skin glow and promotes excellent complexion. One should consume amla throughout the year in any form, fresh fruit or its product. This is a divine herb which promotes health and boosts immunity during the entire year.

How to increase intellect during winter

* *Maalakangani (celatrus paniculatus)* is an intellect-promoting herb. Consume 1 to 10 drops of Maalakangani oil with *Batasa* (a light but hardened sweetmeat made of sugar). Then take a glass of cow-milk. A 40 day course of this herb would improve retentive faculty and memory remarkably. However, one should avoid hot, spicy and sour food items during these days and take milk and ghee. * Consumption of almonds increases strength, intellect, and improves the eyesight. Steep 4 kernels of almonds overnight in water. Peel off the skin in the morning and grind them to a paste manually like the sandalwood on a round piece of stone. Then mix the paste with milk and drink it. Just 1 kernel of almond ground in this manner gives the strength equal to that obtained from 10 almonds consumed otherwise. 1 to 2 kernels of almonds are enough for a child. * Late Prime Minister of India, Mr. Morarji Desai used to take only 7 cashew nuts every day. The consumption of more than 7 is injurious to health. It may damage the kidneys and the liver. Moreover, using almonds without soaking overnight and peeling off its skin would hinder its digestion. * Black sesame seeds are good for physical strength. Consume 10 grams of sesame seeds by masticating them well. Follow it with cold water. Don't take anything during the next 2 to 3 hours. This will greatly nourish the body, besides strengthening the teeth as well as the hair. (It is prohibited for the people having a *Pitta* body type.) * Crush 50 grams each of jaggery and *Ajwaayin* (Indian Henbane) thoroughly. Mix them and prepare small tablets of 6 grams each from it. Organizing Massive Free Food Programme






