Allegation

A girl from Uttar Pradesh charged Pujya Bapuji of molestation on 20th August 2013. FIR was lodged at Delhi's Kamla Market Police Station.

A cock-and-bull story!

The girl says, "Bapuji called me in the room. My mother was sitting outside the room. Bapuji closed the door; and tried to remove my clothes. Then I started screaming. So he closed my mouth. He kept caressing my body for one and a half hour. Then He threatened me saying, 'Don't tell your parents; otherwise I'll kill you.'

When I came out of the room after one and a half hour, I was nervous. Then I went with my mother to the house of the sadhaka, which is just outside the compound of the Kutiya. I told nothing to my parents and went to sleep."

Every move of theirs raises many questions...

Think it over...

- The girl's mother was sitting outside the room; how come she did not hear the girl's cries?
- The girl says that the room was locked from inside for an hour and half and the lights were off. How was it that her mother sitting outside did not knock at the door?
- And why didn't she ask the men allegedly made to stand guard?
- If a girl who has been sexually abused for one and half hour comes before her mother, will not her condition make the mother apprehensive?
- How can a girl having suffered such an assault sleep peacefully?
- In the morning, she played with the farmer's children and while leaving, she gave 200 rupees to them. Is it possible?
- The alleged incident took place on 15th August and the FIR was lodged after 5 days at 2.45 in the night. Why?
- The girl belongs to Uttar Pradesh; was studying at Chhindwara (Madhya Pradesh); the incident is alleged to have happened at Jodhpur (Rajasthan). Why then the FIR was lodged at Kamla Market Police Station Delhi?
- If she had been resisting molestation for one and a half hour with her mouth pressed, would there have been no mark there of on her body?

“The medical report of the girl says that there was no mark of any scratch or tooth-bite on her body. She had not been assaulted either sexually or physically. On being asked by a friend, the girl said, “I said what I was advised to say.”

What is the motive behind such a horrible conspiracy?

* Puja Bapuji advises people to adopt indigenous ayurvedic system of medicine and healing by mantras, meditation, Pranayama, simple living, indigenous products etc. He inspires us to celebrate birthday in Indian style rather than eating 'Happy Birthday' cake contaminated with germs through droplets of saliva transmitted while blowing out candles. 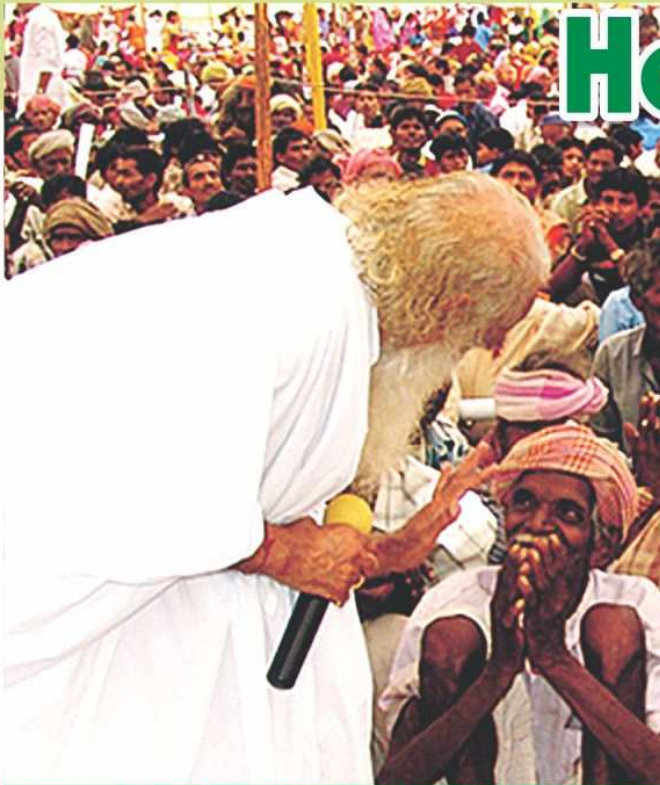

Being a psychologist, I want to explain the pre-planned conspiracy against Sant Shri Asharamji Bapu. It has eight main aspects that will help you understand how things are being manipulated, so that conspiracy is given the shape of truth.

(1) Target Population: In this case, the population, which has been targeted is the educated aware class, elite class and specially the youth of our society. This is so because it's a fact that today's youth has his own independent stand and reacts immediately if convinced with any idea.

(2) Topic of Conspiracy: 'Crime against women', the burning topic in the present context, has been chosen for the conspiracy. Everybody immediately reacts on this emotive issue and is up in arms.

(3) Strategies Used: The Paid Media channels are using marketing strategies to influence public mind. The use of "Consumer Psychology" is being made. For an instance, many times we find an advertisement very odd and weird when we see it for the first time, but after seeing it several times we even don't understand when and how we have started murmuring that advertisement ourselves! Similarly Bapuji's matter is shown again and again and viewers start believing falsehood as truth.

(4) Execution: The way the anchors of paid media channels present a news is not in the form just to "report" but actually they put their 'points' and 'stories' in a sheer dominating way to anyhow convince the audience with their stuff.

(5) Language: They choose such words for a simple thing which will indicate the criminal taste of the incidence. (Ex. Of Hindi words- they say it as-sangeen instead of gambheer, chhapa instead of pooch-taachh, Badaa khulaasa instead of pata chala etc.)



(6) Making Baseless stories, sting operations & other associated points: Like in this case, they said there is "Opium farming" done in the ashrams of Asharam Bapuji etc., such baseless stories are created and matter is made more spicy, expanded and complicated.

(7) Tools of Conspiracy: Distorted and doctored video clippings are shown. Similarly fabricated audio tapes are broadcasted. All these are the outputs of misuse of technology. Apart from this, the people who are being 'used' and 'involved' in this conspiracy to bring the matter on screen are mostly belonging to- the category of weaker/ negative mindsets who either due to greed, fear or revenge get ready to involve in the conspiracy. Ex-Ashramites are used so that automatically it increases the "Reliability Quotient" of their words in the eyes of the common public.

(8) Creating Psychological Atmosphere: If we observe it carefully, all the rumours of threats to the parents of the alleged girl, to the investigating officers, to the chief justice etc. arise just before a day of hearing of the bail. Till now, not a single threat has been proven in any way.

Ask yourself and find the answer to the question, whether it's reporting of allegations or a conspiracy, which is deep-rooted and widespread. One more thing that is noteworthy here is that; it is not only the "Paid Media channels or the electronic Media" which is playing its dangerous role, but actually it is equally the "Print Media" which is causing negative influence of the total fake and cooked stories against Sant Asharamji Bapu. We should be beware of both.

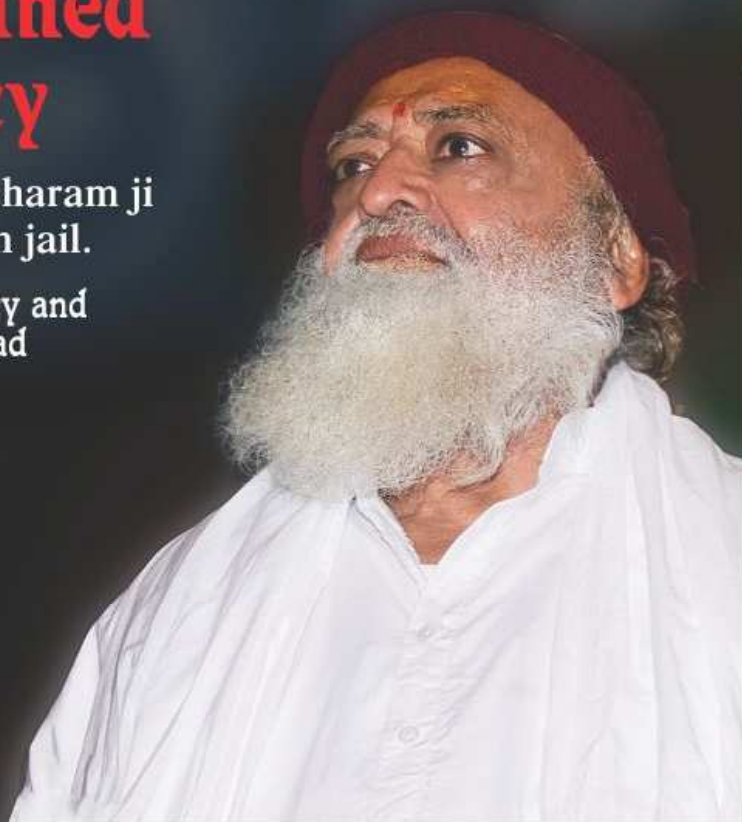
A Well-planned Conspiracy

The FIR lodged by the girl doesn't have any direct or indirect mention of 'Rape' in it. But by using the media they spread the fictitious news that it was a case of 'Rape' and that the 'medical test' has confirmed it.

The medical test report of the girl has completely ruled out

But on account of an unbearable pain attack of Trigeminal Neuralgia ('Ananta Vata', according to the Ayurveda) the ticket had to be cancelled. Here it is worth noting

that this pain is worse than the labour-pain and even that experienced during a heart-attack. Then, in the evening; Pujya Bapuji arrived at the Bhopal airport on His way to Jodhpur via Delhi; however, an extraordinary rush of people and media forced the boarding counter to be closed. We have got those tickets with us to prove this fact.

Despite all the exertion, night vigil and the stress Bapuji undertook a journey by road to His own ashram at Indore. Thus, He didn't flee to any unknown place as was maliciously propagated by the media. Addressing from the Vyasa peetha of the Indore ashram at the night of 31st August; Pujyashree publicly declared to the 167 nations connected through the internet live: "I am waiting for the Jodhpur police, and they are very much welcome here."

Jodhpur police arrived at the ashram. Bapuji said to them, "You do not worry. I am not going to run away. I promise you to give complete cooperation."

The police said that they would take Bapuji by the morning flight at 7:50 to Delhi and from there to Jodhpur through a connecting flight. Pujyashree gave His consent.

They used force and deceit to Arrest Him

At 10:30 p.m. Bapuji went into His room for rest. Then around 11:00 p.m. the police began to move all around the ashram making the devotees stand up from their places, where they were engaged in doing japa peacefully. The police spoke insulting words to the devotees and thrashed them with sticks to vacate the roads in the ashram. Then they made the devotees sit in a confined place and erected barricades all around them. At that time there were more than 800 police personnel inside the ashram. By 12:00 at mid night there prevailed an atmosphere of commotion. Right at 12:00 at mid night a police-jeep entered the ashram. The police then told the ashram sevaks, "We have to interview Bapuji for about 10 to 15 minutes. Please, call Him out."

The sevaks requested them with folded hands: "Sir, He is very tired and is taking rest. Whatever you need to ask, please do it in the morning."

The police began to press for the compliance of their diktat. When they started shouting loudly, Bapuji came out of His room. The police then said, "It's already past 12:00 in the night; so the time limit of the 'summon' sent to you for compliance within four days has just elapsed. Now, we shall take you from here."

The sevaks countered, "Sir, you yourself had told that you will take Him by the morning flight allowing Him to take rest during the night. Now, why are you insisting on taking Him at midnight?"

The police began to shout, "Are we here to obey your orders? Time is over, now we will take Him away."

At this, Bapuji proceeded to board the police jeep; while asking a servant to give His 'aasana'. But the

police misbehaved again saying, "There is no need of such things, just go and be seated in the jeep."

The personal sevak of Bapuji moved fast to put the bag and water bottle inside the vehicle, but the police didn't allow him. Police began to beat the sevaks present there. The devotees ran after the vehicle that carried Bapuji away. The police continued with their lathi-charge on thousands of devotees, as the vehicle whizzed past the ashram gate. Despite having told that they would take away Bapuji in the morning only, the police took Him to the airport at 12:20 in the mid-night itself, as if following the Martial Law. And that is not all. At the airport they kept Him seated until the morning. Even when He boarded the plane; the media persons kept pestering Him.

From Delhi they took Bapuji to Jodhpur by a connecting flight. Hardly had he alighted from the flight, when the interrogation began. As if all this was not enough, they kept on interrogating till 12:30 in the night. This was second night in a row that He couldn't sleep even for a moment. During the interrogation regarding 'sexual harassment' Bapuji said, "I cannot indulge in such acts."

Pujya Bapuji was put under surveillance by the police. Video cameras were fixed. Only one sevak was allowed with Him. Suddenly the sevak noticed inflammation on the right temple of Bapuji. On enquiry, he came to know that it was extremely painful too. Passing sleepless nights had its toll on Him, and the pain attack of Trigeminal Neuralgia was worsening. "Shirodhara" (the continuous flow of warm oil or medicated liquid herb over forehead) was the only treatment that could be given in the police custody of Jodhpur. On seeing the serious condition the Jodhpur police relented and stopped their mind-pestering enquiry to allow immediate treatment. Even MRI brain scan cannot detect all causes of this disease. This is described as the worst pain on many websites. Bapuji has been suffering from this nightmarish disease for the last 13 years; and more than 100 treatment reports of Bapuji can be obtained from Neeta Vaidya.

The troubles the saint endured with infestation of mosquitoes and without medical treatment is known only to him and to God. Media published false reports that facilities like cooler, bed etc. were being provided to Bapuji in jail. But there was nothing of this sort. There was no cooler, no bed and no other facility. The Jail Superintendent himself has confirmed this fact. Whither Humanity? We only pray to God that the inhuman treatment meted out to Bapuji may not be repeated with anybody else.

The sensational news, wherein the concerned girl was time and again mentioned as 'the victim', actually victimized millions of women. Hurt by the arrest of Bapuji with false charges, millions of mothers and sisters have been observing fasts.

Multitudes of false cases related to dowry and



rape have put innumerable men and women, many innocent families and innocent souls in prison, where they are fated to languish for long being victimized by conspirators. Don't such false cases actually strangle the nation and the humanity?

I will bring the Gurukul into disrepute and get it closed

The girl was sick a few days back. She was treated also, and there are documents of her medical treatment. Then she showed signs of mental instability. According to her girl-friends; she used to spend hours in the bathroom; and talk over the phone for hours while strolling on the roof till late night.

One girl student of Chhindawara Gurukul said about the girl: "She did not want to stay in the Gurukul. She was more interested in watching films; talking about boys; and eating fast foods. So to save her from degeneration, her father got her admitted to the Gurukul. It was difficult for her to live in the environment of discipline, eating sattvik food given in the Gurukul, following observances and doing mantra-japa. She used to watch films secretly. She wanted to leave the Gurukul. She used to think out how to get out of the Gurukul. She used to stroll on the roof for hours at mid-night."

Few days before leaving the Gurukul, she said, "I want to earn a good name. I will bring the Gurukul into disrepute. Then it will get closed automatically. Then my father will have no option but to take me away from this place."

To traduce the gurukul; she devised a plan to traduce Babuji. And the easiest way to defame a world-famous saint was character-assassination.

A girl-friend of the girl said, "When I asked her why she falsely accused Babuji. She said, 'I said what I was advised to say.'"

The girl reached Shajapur with her parents. Her brother was also called back from the Chhindwara Gurukul by the police. He showed a positive attitude towards the Gurukul in writing and video-interview before leaving the Gurukul. But then after meeting the conspirators, he said, "Food is not served in the Gurukul. We are starving because only fish and meat are served to us." This is a lie. It is not possible. Many such false allegations were levelled which were published by the local media. The medical report of the prosecutrix says that there are no marks of scratches or bites on her body. No sexual assault or physical assault has been committed to her. In spite of completely normal medical report, the non-bailable section 376 of IPC is still applied. In her statement also, the girl has nowhere said that she had been raped.

What a fictitious story!

The girl said, "Bapuji called me in the room. My mother was sitting outside the room. Babuji closed the door; and tried to remove my clothes. Then I started screaming. So he closed my mouth. He kept caressing my body for one and a half hour. Then He threatened me saying, 'Don't tell your parents; otherwise I'll kill you.'"

When I came out of the room after one and a half hour; I was nervous and frightened. Then I went in the house of the sadhaka, which is outside the compound of the Kutiya, with my mother. I told nothing to my parents and slept."

What an invented tale this is! The girl; who was sick; and who had been treated; who was mentally disturbed; was called with her parents from Chhindwara to Shahjehanpur; and from there to Jodhpur (more than 2000 kilometers); whose mother is sitting outside the room; her parents are present and not even an ordinary or a foolish man could keep a girl's mouth closed with one hand and keep fondling her for one and a half hour; while the farmer's house is very close; and in addition to it; her parents are also there; this is not possible. When the mother is sitting near the door of the Kutiya; why didn't she hear the girl's screams? When a girl of 16-17 years, who has been sexually assaulted for one and a half hour, comes before her mother; do you think that she would not suspect anything on looking at her condition? She complained that she was abused for one and a half hour. How could the girl know the exact duration of time in such a condition? Did she look at the watch before going to meet Babuji, and also check the time after coming back?

According to an officer, "About 98% of rape cases have been proved false. I have seen only 3 cases proved to be true during my entire tenure of 12 years."



What information about the alleged incident does the police have other than the girl's concocted stories? What is the proof in support of her talks? Medical report is normal. The alleged incident took place on 15th August and the FIR is lodged on 20th. Why? The girl belongs to Uttar Pradesh; was studying at Chhindwara (Madhya Pradesh); the incident is alleged to have happened at Jodhpur (Rajasthan). Why then the FIR was lodged after 5 days at 2.45 in the night in Delhi. Why? And why at Kamla Market Police Station? If they come to Delhi from Uttar Pradesh by train, bus or air, there are three main Police Stations on the way. Why the FIR was not lodged there? Every move of theirs raises many questions.

Can the police send such a famous and great saint into jail just on the basis of a baseless FIR registered by a 16-17 years old girl, without having a single strong evidence? False allegations have been levelled against Pujya Bapuji's three devotees also. One of them, Shiva was treated like a terrorist in the name of interrogation. The prosecutrix said that

Shivabhai had called them, and led to the place on 15th August, whereas Shivabhai's train ticket and his mobile phone location reveal that he had left for Delhi in the evening itself. Police forced Shivabhai to sign on a blank paper while on police remand. So, you can just imagine; how much must the police have been

crown of the head). I was physically beaten mercilessly and threatened to speak what I was told to. They brought to me some papers also and forced me to accept and sign that they had found a C.D. from me; whereas I had no such C.D." Shiva sent his complaint to the court also.

Supporting this fact and exposing false rumours propagated by the media DCP, Jodhpur, Mr. Ajay Lamba said in a press-conference, "We have found no such C.D., movie or video-clip. All these are baseless rumours."

Anybody arrested by police must be presented before magistrate within 24 hours under Indian law. Even then Jodhpur (Raj.) police presented Shivabhai before the court only after keeping him on police remand for three days.

Shilpi, the hostel-warden of Chhindwara Gurukul (M.P.), has no contact with Pujya Bapuji for the last six months; personally or over the phone. Jodhpur police went to Chhindwara and put pressure on her also. In addition to it, Jodhpur police also tried to tempt and threaten the girl friends of the prosecutrix and forced them to give statements in

favour of the prosecutrix. The enquiry, which could have been finished in few hours; was dragged on to three days by foul tactics. Being harassed by the police, the students protested and raised a question, 'Why does Rajasthan Police exert so much pressure?' They shouted slogans against the police. Only then the Rajasthan police returned from Chhindwara.

Is it not tangible evidence of the pressure or inducement or some such thing from the temptation? It clearly indicates what terrible conspiracy has been hatched to destroy Indian culture! Otherwise such a great saint, who is serving and awakening the country, and His devotees would not have been treated like terrorists. This is extremely despicable. Just on the basis of baseless talks and reports of a girl; a saint, whose discourses are heard with devotion by crores of people all over the world; with whom the religious feelings of crores of devotees are connected is treated so atrociously. Now let the conduct of the media in the matter of Sant Shri Asharamji Bapu be examined on the touchstone of these eight principles and the conclusion will be for you to draw. Channels

blew the allegations out of all proportions and made it to appear as if the guilt had been proved. And the language used has deteriorated so much that as soon as the allegation was made, use of derogatory language began! 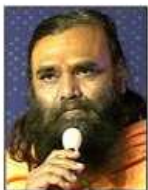

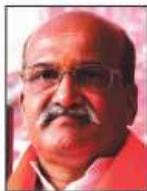

* Formerly it was only the print media that was always intent on proving even innocent saints to be guilty. But today the electronic media has crossed all the limits.

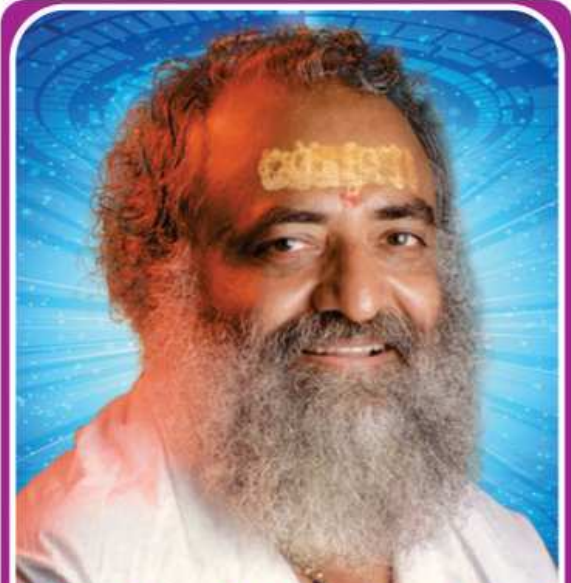

The veracity of the allegations levelled so far!

The antagonists of Indian culture are after Sant Shri Asharamji Bapu and his Ashram who are engaged in the good of humanity at large...

(He has as many wives as he has names) has been published in detail in newspapers like 'Press Ki Taqat'. His co-conspirator Raju Chandak alias Raju Lambu has been caught in a sting operation clearly admitting that he had paid 40000 rupees, supplied liquor and call girls to the Aghori and with the help of media made him to level the allegation of killing contract against Bapuji. The VCD of the sting operation of the conspiracy in detail is available in the Ashram. Anybody can see it. Raju Lambu merrily narrated before the



hidden camera how he had brought the Aghori and kept him at Ahmedabad for five days. On each of the five days, he was supplied liquor and call girls and on sixth day, he was sent to newspaper 'Sandesh'. On seventh day he was taken to Delhi and was handed over to 'India TV'. Such evil minded Sukkha Thug had prepared an audio CD impersonating Pujya Bapuji. In the sting operation Raju is caught mocked the media saying, 'Media is a child. It will play up whatever you give them. Their TRP goes up; their job is done.'

Allegation no. 3 – On 6th December 2009, Raju Chandak alleged that two sadhakas of the Ashram had shot at him in an attempt to kill him.

The truth – There are many facts and inconsistencies that make the alleged firing incident highly incredible.

a) Raju says he was hit by three bullets and continued to drive a motorbike; how is it possible? Wounded as he was by bullets, why did he go home instead of to a hospital?

b) He got himself admitted to a private hospital near home; then immediately he shifted to another private hospital.

c) Raju accused a sadhaka, Gajanan of firing at him. After intensive interrogation Gajanan was found innocent.

It is thus clear that Raju Chandak had lodged the FIR out of malice and it was a well planned conspiracy to implicate Bapuji in false case by abusing the process of law.

This way, one by one, all allegations were proved false and new ones were made.

Amrit Prajapati exposed

Amrit Prajapati has been levelling baseless, false and cooked up allegations against Pujya Bapuji and the ashram on various news channels; but the following are the facts:



Vaidya Amrit Gulabchand Prajapati, who had been expelled from the Ashram, had alleged that black magic was being practiced in the Ashram. In the course of 6-hours-long cross-examination on 13th March 2010, he admitted before the Magistrate D. K. Trivedi of the investigating Commission, **"In the course of my stay at Asharamji Ashram, I never saw any act of black magic. On 8th August 2008, a death threat was sent to Pujya Bapuji through a fax message and a sum of Rs. 50 crores was demanded. The fax message threatened that in case of Ashram's failure to pay the sum asked for, Pujya Bapuji and Shri Narayan Sai would be implicated in false and fabricated cases of practicing black magic, land-grabbing, sexual abuse etc. In respect of the fax message, Amrit Prajapati admitted, "The mobile and land-line phone numbers given in the fax message are mine. I know personally all the people – Dinesh

Bhagchandani from Ahmedabad, Shekhar from Delhi, Mahender Chawla from Panipat, Raju Chandak from Sabarmati, Shakil Ahmed and K. Patel – whose names are mentioned in the fax message."

On not receiving the sum demanded, executing the threat given in the fax message within a week thereof, Amrit Prajapati indulged in the wretched deed of presenting a burka-clad woman before the media and through her falsely accusing Pujya Bapuji of sexual assault. On being cross-examined before the investigating commission on this issue, Amrit Prajapati revealed the truth. He said, "I and my wife Saroj have given statements against Pujya Bapuji to newspersons. To this purpose, I, with my own hands, helped my wife to put on the burka and then presented her before newspersons, who then photographed her. My wife is from Delhi."

A video CD recording the event of Amrit's expulsion from the Ashram on 9th February 2005 was produced before the investigating commission. In the CD, Vaidya Amrit Prajapati had confessed having violated Ashram rules. When Justice D. K. Trivedi, who was astonished to view the CD, asked, "Is it you?" a mortified Amrit Prajapati said, "Yes sir! It is me. I was expelled from the Ashram. It is a fact."

Amrit Prajapati's profligate lifestyle, greedy nature and demoniacal disposition were exposed; when an FIR was registered against him for his evil deeds in Kota, Rajasthan. Pavan Kumar Karamchandani lodged a complaint about Amrit Prajapati's lecherous activities, dissolute behaviour and evil-deeds; such as: incidents of eyeing women lustfully, and untoward incidents of harassing women.

Predictions of Fortune-Tellers:

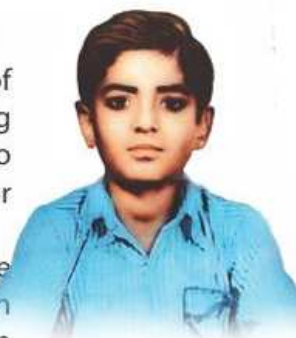

A Siddha Yogi of former life who has come to complete his incomplete divine works of past life. Undoubtedly he will become a great saint.'** Their predictions have come true. And now we see he is a world-renowned Saint!

Childhood:

As a result of partition of India in 1947; his family leaving their entire properties shifted to Ahmedabad due to intense love for India.

For primary education he was admitted to Jaihind High School at Maninagar in Ahmedabad. He had exceptional memory power. After listening once from the teacher; Asumal was able to recite songs and poems etc. instantly it, without difficulty. During afternoon recess in the school, this child used to meditate under a tree alone instead of wasting time in playing and gossiping with friends.

Gradually he developed an attractive and impressive personality among the entire school children due to virtues of his sharp intelligence, humility, one-pointedness of mind and forbearance. His father used to give cashew nuts, walnuts and almonds to Asumal while sending him to school. Asumal out of his kind-heartedness; shared the dry fruits with all students; known as well as unknown. He was brilliant in studies and every year, he passed in first class. Still, he was never impressed by this worldly education. Out of the three Vidyas – worldly education, yogic science and spiritual science (Atmavidya), Asumal was always seen inclined towards the study of Yoga and Self-Knowledge. And it is the wonder of wonders that people having higher learning education having big degrees like M.A., Ph.D., I.A.S. have surrendered and become disciples of this great saint, who studied only up to standard three.



Religious traits inculcated from childhood itself

Mother Mehangiba used to tell him, 'Sit before a picture of God; pray and meditate. God would be pleased by your prayers; and He would give you sweets (Prasad)'. The mother used to place butter and sugar candy (Mishri) in front of Asumal, when he was engrossed in meditation. He would open his eyes and enjoy the prasada of God with utmost devotion. Even while at home, his devotion and meditation went on increasing in tune with the advancement of his age. Japa and meditation awakened his dormant powers.

Discriminating intellect

When Asumal was only ten years, his father Shri Thaumalji left for his heavenly abode. At this difficult hour; Asumal had to give up his studies from class four only to support the family. The fire of discrimination had been kindled in his heart. Asumal's discriminating intellect had firmly convinced itself that world is without substance and God alone is real. He increased the practice of japa and meditation and for intensive sadhana, he went to Siddhapur.

Marriage

As soon as he entered youth, the family prepared to get him married. The dispassionate-minded Asumal did not want to be entangled in the world. Therefore, eight days before the proposed date of marriage, he left his home. After vigorous search, he was traced at an Ashram at Bharuch (Gujarat). Repeated requests of family-members and relatives and also inevitable destiny compelled him to get married; but the bondage could not contain him. He convinced his newly wed polite and pious bride and vowed celibacy till Self-realisation in life. She agreed with these holy and dispassionate thoughts of; her worshipful lord and she also decided to lead a sadhana-oriented and austere life.

Yearning for God-Realization:

Not caring for obstructions and attachment or affection, he set out for achieving his goal. He reached Kedarnath. The priests blessed him to become a millionaire. He had left gold for God and he received the blessing for the same gold! He was not happy with it. He got the puja performed again and received the blessing of God-Realization.

Meeting with the Sadguru

The yearning for God-Realization led him to the forests of Nainital. He met Sai Shri Lilashahji Maharaj after a long wait of 40 days. He was put to severe tests at the Guru's place but the valiant lover of God passed all of them and became a

deserving aspirant for Guru's grace. The supremely kind-hearted Sai Shri Lilashahji Maharaj sent Asumal home after seventy days and instructed him to do sadhana at home in Ahmedabad. He came back home but how could the one, who had been yearning for God-Realization, find peace?

Towards Intense Spiritual Practice

After staying at home for thirteen days; Asumal came to Moti-Koral (Gujarat) on a bank of river Narmada and got absorbed in penance and spiritual practices again. He started an anushthan for forty days. (regular practice of Japa). Here Asumal spent many dark and moonlit nights in the sand on the wide bank of Narmada River lost in the God's supernatural bliss of love divine. He would be spending hours in meditation, deeply lost in God's love without any consciousness of body or the food. He spent hours at a stretch in Samadhi.

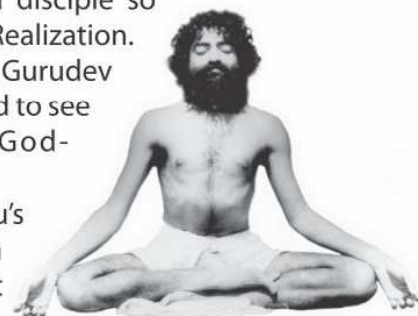
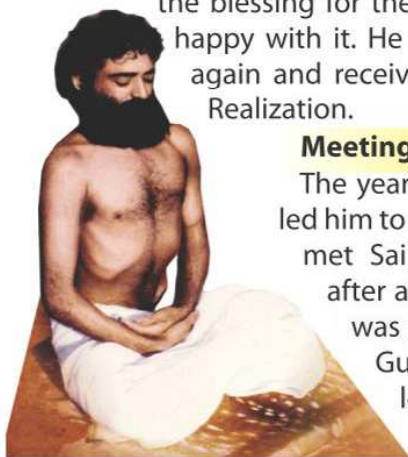
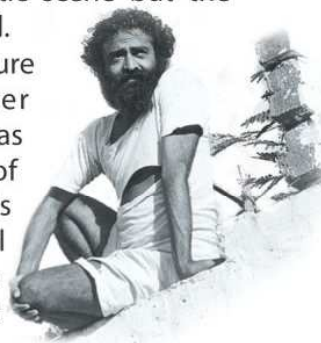
When he was engaged in japa and meditation, that time, his mother and his wife came to take him back home and started crying bitterly. Many hearts were touched to see this pathetic scene but the valiant sadhaka did not budge at all.

The scene of Ashumal's departure from Moti Koral village after completion of his Anushtana, was highly emotional. Thousands of eyes were shedding tears due to his separation. Even the pious local saint Lalji Maharaj also came to see him off up to the railway station. At the railway station of Miyagam, Asumal made his mother and the wife board the Ahmedabad train; and he himself jumped off from the moving train; and boarded a train standing at the opposite platform; and left for Mumbai.

God-Realization

Next day he arrived at Vrijeshwari, Mumbai, where his Sadguru Sai Shri Lilashahji Maharaj had been staying in seclusion. The Sadguru's kind heart overflowed at seeing a disciple so longing for attain God-Realization. Showering his affection, Gurudev said, "Son! I am delighted to see your yearning for God-Realization."

The nectar of Guru's grace flowing from Gurudev's heart brought all his sadhana to fruition. The perfected Guru made the disciple well established in Guru-Consciousness. The sadhaka became a Siddha. On the second lunar day of



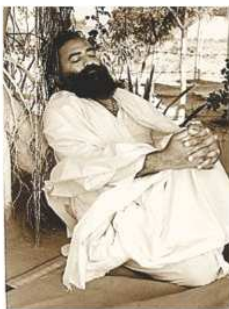


became Sant Shri Asharamji Bapu.

Spiritual Practice in Seclusion

He did spiritual practice for seven long years in Deesa Ashram and the Nala Cave in Mount Abu to experience the depths of Yoga and the peaks of spiritual knowledge. Seeing him perfectly developed in elevating others through Yogic Powers Divine saint Sai Lilashahji Maharaj said, "You have developed the seed I had given to you into a tree. Now you distribute its sweet fruits to the people. The world suffering from sins, afflictions, grief, sorrows, tension, enmity, rebellion, arrogance, unrest and agitation needs you."

Showering His blessings; the supreme benefactor said once again, "Asharam! You give out your spiritual fragrance like a rose; and the world will know you. Now by leading a householder's life, you distribute the gifts of spiritual blessings to relieve the people suffering from sins, afflictions, grief, tension, diseases and sorrows; and awaken them in their own Self."



He stayed in blissful solitude at Deesa Ashram on the bank of Banas River rejoicing in spiritual bliss. Many people started coming at his feet to get peace by taking a dip in the river of his experience-soaked satsang (satsang of realisation) and getting solution to their problems.

From there, He left for Nareshvar; and he reached a deep uninhabited forest on the banks of Narmada river. There, He sat under a tree; and got engrossed in Self-meditation so deeply that the entire night was spent. He came to waking consciousness from the deep meditation in the morning and completed the daily obligatory rites. Then, He felt hungry. But He thought; 'I will not go anywhere for begging alms; I will eat sitting here only. If the creator of the universe feels the

compelling necessity, He Himself will bring the food for me.'

And really the same thing happened. Two farmers arrived there with milk and fruits. In spite of serious refusal by Him, they insisted and said, "We have arrived in your service only through the divine inspiration."



Some mysterious power showed us the path in the dream at night; and has sent us to offer you this food." He took some milk and some fruits; and left that place too; and kept enjoying the supreme bliss of Jivanmukti, (being liberated while living) in the caves of Mount-Abu and secluded forests and caves of the Himalayas.

After a gap of seven long years; on being persuaded and instructed by His supreme benefactor and honourable Sadaguru His Holiness Swami Shri Leelashahji Maharaj; and in order to keep the words given to His honourable mother, He stepped on the land of Ahmedabad on Thursday 8th July 1971 or on Guru-Purnima of the Vikram Sanvat Year 2028.

Establishment of the Ashram

On January 29, 1972, the devotees constructed a temporary 'Moksh Kuteer' on the uneven land on the bank of Sabarmati River. There were thorny bushes, rough and uneven forest all around in this area; where people were afraid of robbers even in the day time. But after the establishment of the Ashram; the viciously



fearful and ominous environment of this area changed all together. Established in the fearful place of Sabarmati River; this hut of Sant Shri Asharamaji Bapu has become a great and pious place of pilgrimage in the name of 'Sant Shri Asharamaji Ashram.' Today, the branches of this huge tree in the form of 425 Ashrams have spread not only all over India; but in many countries of the world. Today crores of people of all castes, religions



and countries enjoy the nectar of meditation and satsang (spiritual discourses); and get blessed by solving their painful riddles and knotty problems of lives.

Pujya Bapuji lives by the principle: May good and propitious come to all.

He says, "Nobody should be regarded as bad; instead, we should try to rid him of evil and vices."

He inspires all to live a life of righteousness and virtue following the path of selfless work, Bhakti and Self-Knowledge. He provides us the keys of kirtan and prayer to enable us to live a happy, healthy and respectable life. Even a rank atheist cannot escape the enrapturing effect of his kirtan "Madhur madhur naam Hari Hari Om". Many atheists have turned to spirituality listening to this kirtan.

There is no legally acceptable evidence in the complaints against Pujya Bapuji; they are mere allegations. Whenever a complaint is lodged, it is the legal liability of the police to make a preliminary enquiry. Only if prima facie evidence is available should a case be registered. This is the rationale of court judgements. But in this case, the case has been registered without any preliminary enquiry. This is contempt of law.

There is no eye-witness in case of rape. The case is always based on circumstantial evidence. Medical evidence is a must, which is impossible to find in this story. Secondly, the complainant stayed in the Ashram for seven years after the alleged assault. When the alleged assault was made against her will for seven years, why did she continue to stay in the Ashram for seven years? This is a big question. Moreover, she was an orator. She had gone to many states for delivering discourses. She never mentioned this alleged incident nor did she ever discuss this incident with anybody. And when after twelve years, the alleged Jodhpur incident surfaced, she started speaking. This fact by itself proves that this is a cock and bull story and nothing more than that.

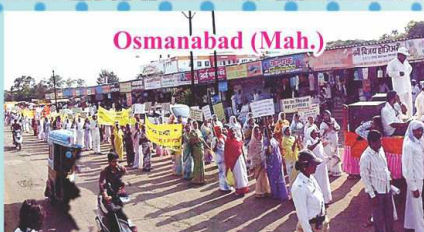
